# FEBRUARY 2021 MINUTES APPROVED MARCH 15, 2021

Members of the Northampton Housing Authority met via "Zoom" on Monday, February 22, 2021 at 6:54 P.M.

Joella Tarbutton-Springfield – the dogs are making a mess outside, there is a lot of foot traffic on the side of the building next to the Senior Center and there is a lot of dog poop. Can we have a place to put the dog waste in?

Cara noted that NHA is 58.33 percent through the budget for the year and we are under budget on most items due to COVID.

Discussion - Update on Residents & Staff on the COVID vaccine

On February 18, 2021 the residents and staff were eligible for the COVID vaccine. Board of Health in Northampton is not interested in a partnership. All residents are eligible for vaccine. The RSC's are helping residents in getting appointments. All residents should be vaccinated by sometime next month. Chairperson Richards – any other questions on this?

Commissioner Silver - Have you contacted CVS, Walgreens, etc.?

Cara – If the Board of Health partnered with us they would have gone to the properties to administer but they don't have the manpower to do that. We have reached out to pharmacies and doctors.

Commissioner Silver – is there any way of getting a priority at Eastfield Mall or UMASS? DHCD? This should be a high priority.

Cara – we have given letters to residents and staff that they can use to obtain the vaccine. DHCD and the Governor did move us up on the list. RSC's are trying to work with the residents.

Commissioner Silver – do the tenants know that they can get help from the NHA.

Cara – yes.

Commissioner Tarbutton-Springfield – I got a robo call the other day and I got my vaccine.

Commissioner Silver – for next month's agenda – can we have a conversation of when the Board packets go out. Receiving them on a Friday evening for a Monday meeting doesn't give me enough time to read through everything.

Chairperson Richards – do we have a preview of next month's meeting?

Commissioner Silver – vote to change the bylaws on what we decide.

Cara –better to put this on the April agenda, there is a lot for the March meeting.

Vice Chairperson Brooks put forth the motion to adjourn the February meeting at 7:19 P.M., seconded by Commissioner Silver.
